Suitable and Unsuitable Extinguishing Media: Use water spray or fog, foam, carbon dioxide or dry chemical. **Special Hazards Arising from the Chemical:** This compound will not burn unless it is pre-heated. Water fog may be used to cool the containers but do not spray directly into large containers of burning liquids as frothing may occur. Dense smoke and noxious or toxic fumes may be generated in a fire. The thermal decomposition products are highly dependent upon the combustion conditions. Noxious or toxic fumes may be generated, some of which may be toxic or irritating.
