Suitable and Unsuitable Extinguishing Media: Use water spray or fog, foam, carbon dioxide or dry chemical. **Special Hazards Arising from the Chemical:** This compound will not burn unless it is pre-heated. Water fog may be used to cool the containers but do not spray directly into large containers of burning liquids as frothing may occur.
